Extended Care Program

The Clover School will offer Extended Care during our Summer Camp 2025 program. Due to ratios and staffing, we cannot accept children on a drop-in or hourly basis, except in the case of emergency or individual assessment. **Please note that extended care hours are shortened from the regular school year.**

Extended Care Fees:

Morning Extended Care (8:00 to 9:00 a.m.) - see fee schedule for applicable amounts

Afternoon Extended Care (4:00 to 5:00 p.m.) - see fee schedule for applicable amounts

Both Morning and Afternoon Extended Care - see fee schedule for applicable amounts

Our Extended Care Program ends promptly at **5:00 p.m.** There will be a **\$5/minute** charge for any student(s) picked up **after 5:00 p.m.** If your child is not registered in our Extended Care Program and

they are dropped off at camp earlier than 9:00 a.m. or if they are not picked up by 4:00 p.m., you will be charged a daily rate early drop off/late pick up fee.

Terms and Conditions

Registration Fee: All students must pay the applicable camp deposit upon enrollment to hold a space for the camp year in which the application is being submitted. The camp deposit is due once placement has been offered by the camp. This fee is a portion of your child's overall camp fees and is irrevocably non-refundable.

Responsibility for Payment of Fees: All parents/guardians are responsible to pay The Clover School, a division of Forest Hill Montessori School Inc. ("The Clover School"), the charges for the full camp program. Payments can be made by Pre-Authorized Direct Debit or credit card. Please note that credit card charges for any payments incur a 3% service fee. In the event of default in the payment of any installment provided for in this contract, a camper may not be allowed to continue with the camp program and parents / guardians will be responsible for all legal fees and reasonable costs of collection for any outstanding amounts due under this contract. There is no transfer of fees from one student to another, nor from camp to the academic school year. Camp group placement for students is at the discretion of the Administration.

Any student whose account has not been paid promptly or is in arrears may not:
- be permitted to attend camp
- be provided with tax receipts

Withdrawal: Any notice of withdrawal must be made in writing. The Camp Deposit Fee is non-refundable, with no exceptions. If a parent/guardian wishes to withdraw a camper after enrolling, the following conditions apply:

- Withdrawal on or prior to April 30, 2025: 100% of fees will be canceled and/or returned (excluding Camp Deposit).

- Withdrawal on or after May 1,2025: 0% of fees will be canceled and/or returned (including Camp Deposit).

Late Payments, NSF Fees: All late payments are subject to 1% interest per month (12% per annum). There is a \$100.00 fee applied to any NSF PAD payments or delinquent/declined credit card payments.

Tax Receipts: Tax receipts are provided annually via e-mail each February.
